## **UNITED STATES NATIONAL EXPOSITION JUDGING: FREQUENTLY ASKED QUESTIONS**

### **What is the Enactus United States National Exposition?**

Annually, the Enactus United States National Exposition brings together student, academic and business leaders from across the country to celebrate the achievements of future leaders and entrepreneurs. Over the course of the three-day event, students showcase their projects and business ventures that enable progress through entrepreneurial action. Through rounds of live, presentation based competition, business leaders serving as judges determine which Enactus team will be named National Champions and represent the U.S. on the global stage.

The competitive process, along with additional programming, provides an opportunity for collaboration and best-practice sharing, fosters innovation, encourages results and rewards excellence in entrepreneurial leadership.

### **Do I need to prepare in advance for my role as a judge?**

No – you will receive all the required training and materials on-site at the Enactus United States National Exposition.

### **How many presentations will I be judging?**

Opening Round of Competition: 5-8 Enactus team presentations. Semi-Final Round of Competition: 5-8 Enactus team presentations. Final Round of Competition: 4 Enactus team presentations.

### **How long are the presentations?**

Enactus National Competition: 25 minutes (3min set-up, 17min presentation, 5min Q&A)

### **How many judges will there be?**

Each competition room will have 12-15 judges, except for the Enactus Final Round of Competition which will have 50+ judges.

### **Who are the other judges in the room?**

Judges at the Enactus United States National Exposition are representatives from Enactus United States corporate and organizational partners along with alumni of the program and other invited business and community leaders.

### **Will the students receive feedback from the judges on their presentation?**

Yes – evaluation sheets completed by judges are provided to the Enactus teams following the event.

### **Will there be food provided at the Enactus United States National Exposition for the judges?**

Yes – dependent on the time of your judging session, a light breakfast or lunch will be provided prior to your competition. Coffee and assorted beverages will be available throughout the day for all judges at the event.

### **What is the dress code for judges at the Enactus United States National Exposition?**

Judges are asked to dress in business attire.
